

## **CONTEST CLUB RULES – 11/29/18 Revised**

These rules define how listeners can win tickets to various events via on line entering at the NRG Media CONTEST CLUB which appears from time to time on [www.rivercountry1017.com](http://www.rivercountry1017.com), [www.am1460wixn.com](http://www.am1460wixn.com), [www.SKY957.com](http://www.SKY957.com)

These contest rules are specific to the CONTEST CLUB Contest(the “Contest”) conducted by NRG Media, LLC d/b/a WRCV River Country 101.7, AM 1460 WIXN, WSEY SKY 95.7 (the “Company” or the “Stations”). Except to the extent specifically set forth below with respect to this specific contest, the Station’s general contest rules apply to this contest. These rules are intended to supplement the General Contest rules, however, to the extent that the general contest rules differ from these rules, these rules will govern and control with respect to this Contest.

Only one winner of tickets per address or household. Rules for specific methods of entry are listed below.

NRG Media and participating stations are not responsible for mechanical failures or lost entries.

#### **ENTER ONLINE**

You will be asked to provide your name, email address, and phone number, and be asked to reply to various questions. You will receive an email confirming your entry. By entering you consent to receive email from WRCV River Country 101.7, AM 1460 WIXN, SKY 95.7.

Then listen to WRCV River Country 101.7, AM 1460 WIXN, SKY 95.7 on the specific date the tickets will be given away. The Winner will be announced on the Station conducting that contest between 6 a.m. and 9 a.m. The Station will email the Winner to confirm they’ve won. The Winner must pick the tickets up from the studio on or before 3:30PM at least 48 hours before the ticketed event or tickets will be forfeited.

Value of the ticket prize packages will vary. Prize package includes tickets only.

All decisions by NRG Media management are final. Odds of winning depend on number of entries.

### **Publicity; Use of Personal Information.**
